# An important message from the OLRA Board

In an effort to support and enhance pool safety this year, we will be offering all families access to red adjustable wristbands. If you feel like any member of your family (or a guest) would be at a greater risk in the pool due to their swimming ability, you will now have an opportunity to put a wristband on them prior to entering the pool. These wristbands will indicate to the lifeguards that that person is a weaker swimmer and allow them to keep an extra eye on them. Lifeguards will continue to monitor the safety of everyone in the pool, but these wristbands will help lifeguards better identify the weaker swimmers from the stronger ones. Children wearing the bracelet are required to use a personal floatation device (PFD) in the pool that is approved by the US Coast Guard. PFDs that are approved by the US Coast Guard will have a label stating so. Blow-ups, inflatable arm rings, and pool noodles are NOT approved devices. Once the date for the swim test is set, an email will be sent to the residents.

If you are not sure if your family member needs a wristband, lifeguards are available to administer a swim test to determine their risk level all season long. A supply of wristbands will be available at the club house when you pick up your stickers or at the lifeguard table as you enter the pool. Please take as many as your family might need. These wristbands are only meant to be an additional layer of safety for your family and should not replace parents or guardians from watching their children in the pool.

## **RULES AND REGULATIONS**

### **2024**

#### **GENERAL RULES**

(Tennis/Clubhouse)

1. Association members must carry their photo IDs and sign in at the clubhouse office when using any recreational amenities.
2. Tennis/Pickleball courts are available on a first come first serve basis.
3. Use of the tennis/pickleball courts is limited to 1 hour unless there is no one waiting to use them.
4. No skateboarding, rollerblading or bicycling on the clubhouse parking lot.
5. Swimsuits, wet or damp, will not be allowed on the upper level of the clubhouse at any time.
6. No alcohol is allowed on the lower level of the clubhouse.
7. Shirts and shoes are to be worn inside the clubhouse.
8. Children under the age of 11 years must be supervised by an adult while in the clubhouse.
9. Children under the age of 14 years will not be allowed in the lower level of the clubhouse.
10. The weight room minimum age is 18 years, but parental consent forms are available for 14-17 year olds. Residents under 18 years of age may not bring a guest to the weight or exercise rooms.
11. Residents can make appointments for the treadmill or elliptical equipment up to one day in advance (30 minute increments). There is no charge to use the treadmill or elliptical equipment. Note: maximum weight is 300 pounds.

#### **POOL RULES**

1. Resident members are responsible for knowing the rules and explaining those rules to their children and guests.
2. Admission to the pool is limited to current OLRA ID card carrying members who are in good standing with the association. If you do not have an ID you must report to the office to have one made for you.
3. Any homeowner or resident that is delinquent on their Recreational or Homeowners assessment are restricted from using the clubhouse and pool facilities as a resident or guest until all assessments and fees are paid and up to date.
4. No children under the age of 11 years will be permitted in the pool area unless closely supervised by a responsible adult (16 years old or older). Non-resident babysitters must also have a "babysitter" ID from the clubhouse. This photo ID will be for that sitter to bring only the sponsor family's children to the pool. The cost for a Babysitter ID is \$20.00, limit one per resident address.
5. When in the swimming pool, children under the age of 12 must be supervised by a responsible person over the age of 16 in swim wear, and that person must always be within arm's length of the children in the pool, unless children have passed the required swim test.

## **6. SWIM TEST REQUIREMENT –**

In order to swim in the pool without supervision, children under the age of 12 must pass a swim test administered by a lifeguard. The swim test will include swimming the length of the pool and treading water for 60 seconds. Children who do not pass a swim test, or whose parent or guardian is not confident in their swimming ability, must wear a red colored wristband issued by OLRA/UNIQUE POOL to be worn at all times when in the pool. Children wearing the bracelet are required to use a personal floatation device (PFD) in the pool that is approved by the US Coast Guard. Approved PFDs will have a label stating that they are approved by the Coast Guard. Pool noodles, blow-ups, and inflatable arm rings are NOT approved as floatation devices. Once the date for swim tests is set, an email will go out to all residents.

7. No one under the age of 18 years will be permitted in the adult pool.

The lifeguards on duty have full authority to enforce a discipline policy to individuals not conducting themselves in a proper manner. Some examples of inappropriate behavior include cursing, pushing, rough play, malicious dunking, verbal abuse, intoxication, and disrespectful behavior toward lifeguards or others & smoking in areas not designated for smoking.

The lifeguards are authorized to ask anyone to leave the pool area when the following incidents are noted within a single day:

1<sup>st</sup> Incident- Lifeguard will issue a warning stating, “This is your first warning!” and will determine identity of the individual.

2<sup>nd</sup> Incident- Lifeguard will issue a second warning stating, “This is your second warning!”

3<sup>rd</sup> Incident- Lifeguard will eject the individual from the pool for the day.

When ejected from the pool, the individual’s ID will be “snipped”, confiscated, and sent to the office. An individual will not be permitted back into the pool without possession of their ID. An ID can be reclaimed as follows:

For Minors:

1<sup>st</sup> Ejection- The pool office will call the parent; discuss the circumstances and arrange for a time at which the ID can be reclaimed.

**2<sup>nd</sup> Ejection- Someone from the Parents board will call the parents, discuss the circumstances, and arrange for a time at which the ID can be reclaimed.**

**3<sup>rd</sup> Ejection- The parent must meet with representatives from the OLRA Board and the Parents Board. The minor can no longer come to the pool unless escorted by the parent. Upon a 3<sup>rd</sup> ejection, the ID card will have 3 corners “snipped” (once for each ejection)- pool employees will not allow admittance into the pool unless accompanied by a parent.**

For Adults:

**First Incident: Lifeguard will issue an immediate warning. If the offender does not immediately comply, the Lifeguard will eject the offender and they will not be permitted to return to the pool until they have a meeting with the OLRA Board.**

**Second Incident: Lifeguard will issue an immediate pool ejection and will result in loss of pool privileges.**

**Offender will also be advised that St. Louis County Police may be contacted if the offender does not comply. Offender will also be financially responsible for any damages to the pool or pool area.**

1. Cans, candy wrappers, and other waste materials are to be placed in the proper disposal containers.
2. Food & drinks will be permitted only in designated areas. These areas will be strictly enforced. Cans and plastic/paper cups will be allowed, but NO GLASS OR GUM may be used in any area of the pool grounds. *Per the St. Louis County Health Department – food and/or drink may not be consumed or served within eight feet (8') of the water's edge. Food and beverages served or consumed in designated areas shall be in unbreakable containers. Failure to abide by said rules and regulations of the St. Louis County Health Department will result in closure of the swimming facility.* No Smoking will be allowed inside the fenced area around the pool decking, inside the Clubhouse or up on the deck. There will be a designated "Smoking Area" outside the fenced area, and will be clearly marked with "SMOKING ALLOWED" signs posted on the wood picnic tables.
3. Improper or unnecessary conversation with lifeguards and/or pool staff, interaction with the lifeguards and/or pool staff or harassment of any type with the lifeguards and/or pool staff will not be permitted. The lifeguards have full authority on the pool deck. If there is an issue not being addressed by the lifeguards, contact the office staff.
4. Air mattresses, swim fins, tubes and water snakes shall be allowed, but may be limited to times when the lifeguards feel that their use will not interfere with other swimmers' use of the pool or their safety. Torpedo type toys and dive sticks are not permitted. Diving rings are permitted.
5. No oily type suntan lotions will be permitted in the pool. Suntan lotions must be in unbreakable containers.
6. Showers should be taken before entering any of the pools.
7. Chairs and tables are primarily for the use of adults.
8. Only swimming apparel will be allowed while swimming. No shorts or cut-offs.
9. The pool may be closed for maintenance purposes, health conditions, weather conditions, or any other reason deemed sufficient by the pool management.
10. Pets are not allowed in the pool area with the exception of Service Animals, which will require prior Authorization in the form of a Doctor's note on file at the Clubhouse.
11. Due to insurance regulations, no resident or guest is allowed to conduct swim lessons free or paid for on clubhouse or pool premises without written consent from the board of directors.
12. Pool Safety is EVERYONE'S responsibility, both Lifeguards AND Parents.

**All rules are subject to change without prior notice if conditions so require.**

**\*Failure to abide by the rules and regulations could result in loss of some or all membership privileges.**

## **REGULATIONS**

**\*All rules are subject to change without prior notice if conditions so require.**

**\*Failure to abide by the rules and regulations could result in loss of some or all membership privileges.**

**\*The pool and clubhouse may be closed for reasons deemed sufficient by the Board of Directors or their representatives.**

**\*The Recreational Association and its staff will not tolerate the presence of any type of weapon (BB gun, dart gun, pellet gun, or any other type of gun, bow and arrow, knife, etc.) in the clubhouse facility or on clubhouse grounds. OLRA has the ability and responsibility to take away clubhouse privileges from any and all offenders.**

**\*Illegal drug use and those suspected of being under the influence of said substance (including children under the age of 18 smoking cigarettes or minors under the age of 21 drinking alcoholic beverages), can and will be subject to forfeiture of privileges associated with use of any recreational amenities.**

**\*The recreational association does recognize all county and state laws and ordinances.**

# Life Guard Duties

## Opening procedures:

- Unlock all doors and return keys to lock box
- Turn on features, electronics, etc.
- Make sure bathrooms are clean, trash cans are empty, and pool deck is clean of debris and trash.
- Check and log chemicals
- Check for safety hazards and report to the appropriate person
- Skim the top of the pool of any debris
- Vacuum the pool
- Locate all emergency equipment

## Closing Procedures:

- Move all pool furniture to original location
- Put down umbrellas
- Pick up all trash on the pool deck, replace trash can liners, take all trash out to the dumpster
- Wipe down bathroom mirrors, sinks, door handles, toilets, etc.
- Check for safety hazards and report to the appropriate person
- Put away all emergency equipment
- Turn off all features, lights, etc.
- Lock all doors and return keys to lockbox



Residents, please check all goggles that you bring to the pool and make sure they are not made with glass. We don't want another incident where we have to drain the pool again. Thanks!

- \* Representatives from Unique Pool provided an update. They are painting new lines, fixing concrete and putting in new lighting in the adult pool as well as repairing the ladders according to St Louis County specifications. They have a full staff of lifeguards and will be ready for opening day.
- \* Discussion was had regarding lifeguard responsibilities and resident safety measures. It was mentioned that residents should be aware of what lifeguards duties are to help improve residents experience at the pool and lifeguards job compliance. Additionally, wristbands were suggested to help lifeguards identify weaker swimmers. It was discussed to leave the decision to wear a wrist band up to the adults with the child rather than trying to have lifeguards “police” it. This will be further discussed at a lifeguard training meeting to be held in May.

- In addition to her handout, Connie reported that the grout medics were back for a 2<sup>nd</sup> cleaning and that the bathroom repairs and updates will be ready to go for pool opening day. The deck is also being repaired and stabilized and will be ready for pool season. 2 umbrellas have been purchased to replace broken ones.

## **Clubhouse Rentals**

Too many relatives and friends to host your party at home? The clubhouse is available for rentals 365 days a year, even on holidays! You can view our rental calendar at [www.oakslanding.org](http://www.oakslanding.org) or by calling the clubhouse at 636-225-2183.

The clubhouse only accepts checks for payment.

The clubhouse rental prices are:

Monday - Thursday	\$25 per hour
Friday - Sunday	\$35 per hour
Holidays	\$45 per hour

A deposit check of \$150 is also required per rental.

**A minimum of 4 hours is required for all rentals. Set up and take down time are included in the 4 hours. If additional time is needed, appropriate rental fee applies.**

For example, if you reserve from 11am – 3 pm, you may begin set up at 11am and you must be cleaned up and out by 3 pm. We need one hour for our staff to clean between rentals so please make sure you give yourself enough time. Thank you in advance for your consideration of the rental following yours.

**Non Profit Organizations** - require a \$25 deposit check

\$15 for 2 hours and each additional hour is \$10.

Non profits may rent the clubhouse during normal business hours Monday - Friday.

**NOTE: Only members of Oaks Landing Recreational Association may rent the Clubhouse and members must be present during the entire rental time**

# **“What Do All of These Acronyms Stand For?”**

## **ROHA, NLHA, OLRA: What You Need to Know**

### **1. So, what do the acronyms stand for?**

ROHA — Remington Oaks Homeowners Association

NLHA — Newport Landing Homeowners Association

OLRA — Oaks Landing Recreational Association

### **2. What does each association actually do?**

ROHA governs the Remington Oaks and Chestnut Pointe neighborhoods (AKA the “tree-themed” streets), and NLHA governs the Newport Landing neighborhood (mostly “sea-themed” streets on the other side of Hawkins). Homeowners belong to ONE of the two organizations based on their address. OLRA governs the Clubhouse, swimming pools and tennis courts.

### **3. Can you give me a refresher on the annual assessments?**

Each resident receives two assessments each year: one from either ROHA or NLHA, and one from OLRA. The ROHA and NLHA assessments are distributed in late December and are due Feb. 1 each year. The OLRA assessments are distributed in late January and are due March 1 each year.

### **4. What, exactly, do the fees cover?**

ROHA fees cover common ground maintenance (including Lake Remington), main entrances maintenance, insurance and streetlights for the Remington Oaks and Chestnut Pointe neighborhoods. NLHA fees cover trash pickup, common ground maintenance (including the Newport Landing pond), main entrances maintenance, insurance and streetlights for the Newport Landing neighborhoods. OLRA fees cover Clubhouse maintenance, insurance, swimming pools, tennis courts, fitness rooms, and Clubhouse-sponsored neighborhood activities.

### **5. I don't ever use the Clubhouse facilities. Do I still have to pay the OLRA fee?**

Yes. Per the governing indentures, all households are required to pay both the appropriate Homeowners Association fee and the Recreational Association assessments.
